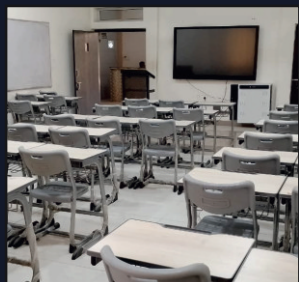


Library

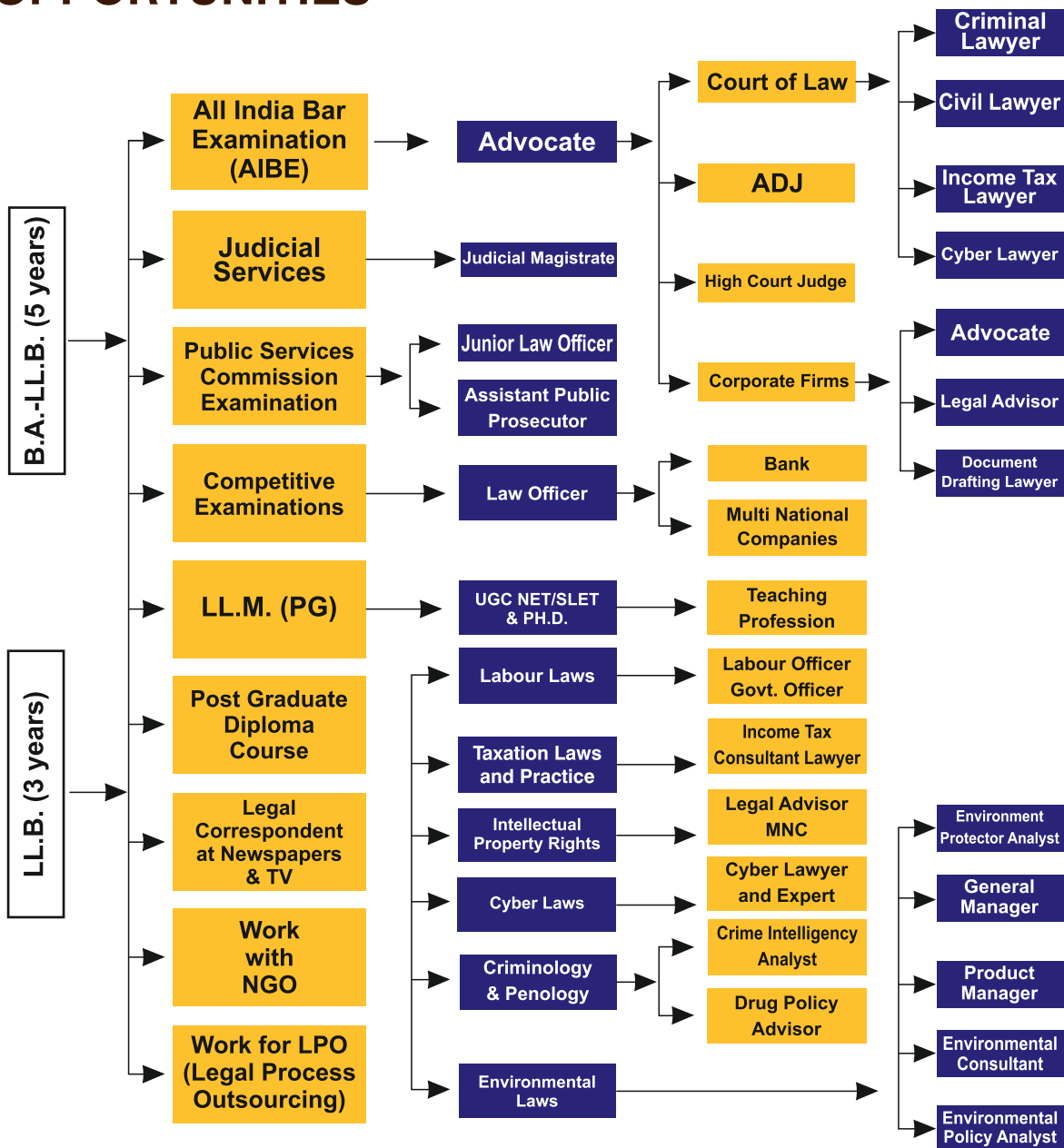

Eligibility Criteria

1. B.A.-LL.B. Five Years Integrated Course

Eligibility : The candidate must have a minimum of 50% (45% for SC/ST and 47 % for OBC) marks in any stream of the 10+2 examination.

2. LL.B. Three Years Professional Degree Course

Eligibility : The candidate must have a minimum of 45% in graduation or postgraduation (40% for SC/ST and 42% for OBC) marks in any stream.

3. LL.M. Two Years P.G Degree Course

Eligibility : The candidate must have a minimum of 55% in law (50% for SC/ST and OBC).

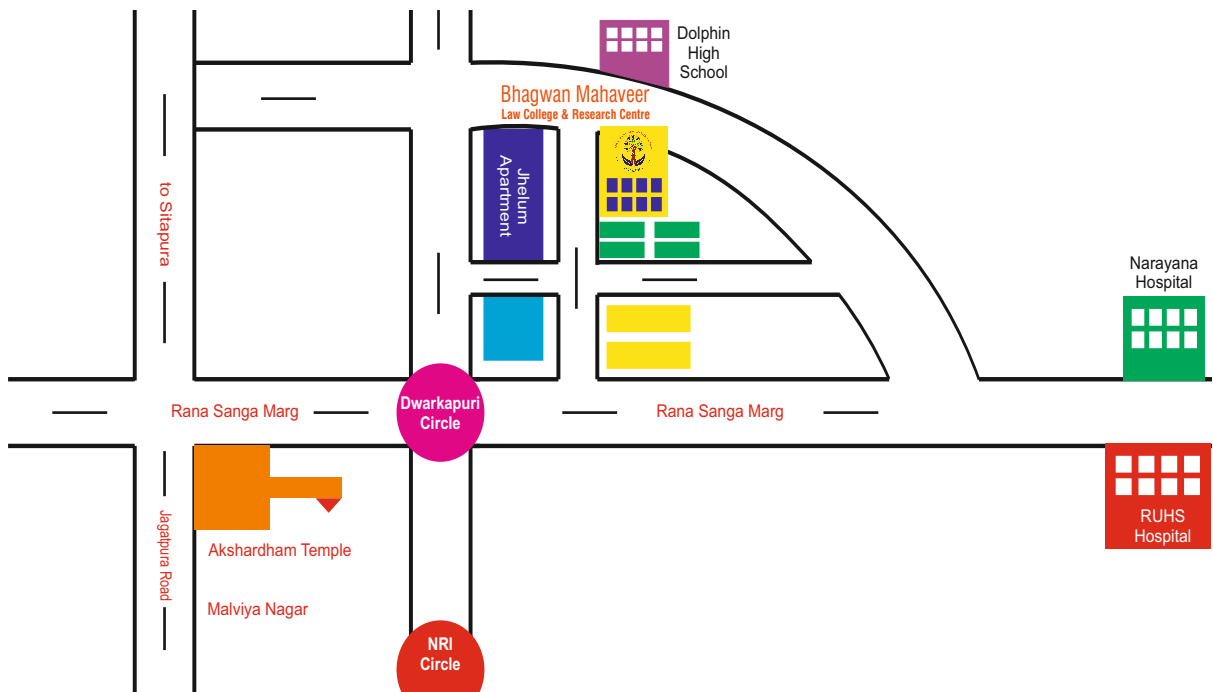
